Notification Updates Regarding New Online-Application-Form and Online-Appointment-System

Starting from 10thApril 2019, a new version of the Chinese visa application form will be used and the online appointment system will be implemented by the Chinese Visa Application Service Center in Frankfurt (hereinafter referred to as "Visa Application Centers").

If you choose to submit your application in the visa Center in Frankfurt and Dusseldorf, please read the steps illustrated below carefully:

1. Navigate to theChinese Visa Application Service Center’s website, and select Germany, in order to arrive at the Frankfurt and Dusseldorf Center’s homepage.
2. Read the specific "Step by Step Guidance" section’s information regarding your particular purpose of visit and your visa requirements.
3. Enter the "Quick Access" section from the homepage, and then select "Online Application Form" to fill in your application form online. The online application form will require you to upload a recent standard photograph (please [check here](#) for photograph requirements). If the online form indicates that the photo is not qualified and cannot be uploaded successfully, please be sure to bring an appropriate photograph to the center when you come to submit your application.
4. After filling in the application form, please prints out the complete form, sign on the confirmation page and the 8th page of the application form.
5. Enter the "Online Appointment" section, fill in the application form number which is automatically generated and it started with "FRA" or "DUS" (If you wish to bring more than one application with your appointment, you must ensure you enter all application form numbers for all applications under the appointment number. One appointment can be booked for up to five applications). Choose a time slot and finish the appointment booking. The system will automatically send you a confirmation email. Please print the confirmation email out or screenshot the appointment time information and show your appointment while you arrive at Frankfurt or Dusseldorf Visa Center.

Matters need attention:

1. Online application form is currently only available in Chinese and English.
2. From 10thApril to 9thMay 2019, the Visa Center will still accept the old application form (four sites). You don’t need to make an appointment if you submit your application with the old application form.
3. From the 10thMay 2019 the Visa Application Centers will only accept online application form with appointment booking. The old application form will not be accepted. Except humanitarian visa, an online appointment must be booked before you come to the Chinese Visa Application Center to submit your application.
4. You should fill in this form truthfully, completely and clearly. Please note that if you provide false, fraudulent or misleading information or documentation, your application will be refused.
5. Visa Application Centers cannot acceptService, diplomatic and courtesy visa applications. Service, diplomatic and courtesy visa applicants can still fill in an online application form on our website, print out and sign. And you will be required to directly to competent Chinese Embassy and Consulates to submit application materials.
